### SECTION 4 FIRST AID MEASURES

<b>Inhalation</b>	If inhalation of mists, fumes or vapour causes irritation to the nose or throat, or coughing, remove to fresh air. If symptoms persist obtain medical advice.

## SECTION 6 ACCIDENTAL RELEASE MEASURES
