SECTION 4 FIRST AID MEASURES

4.1 Description of first aid measures

SECTION 5 FIRE-FIGHTING MEASURES

- 5.1 Extinguishing media Foam, dry powder or water fog. Water can be used to cool and protect exposed material.

- 6.1 Personal precautions, protective equipment and emergency procedures Immediately evacuate all personnel from danger area. Wear Personal Protective Equipment. Eliminate all sources of heat, sparks, pilot lights, static electricity and open flames. Spilled material may make surfaces slippery.
